

# Campus Climate Survey


The 2019 Campus Climate Survey was modeled after the [2015 AA&U Campus Climate Survey on Sexual Assault and Sexual Misconduct](#). On April 2, 2019, the survey was distributed to 2,912 undergraduate students and 1,211 graduate students. Nine reminder e-mails were sent to non-completers over the course of a month, yielding 403 respondents (9.8% response rate). All questions were optional.

In accordance with NYS 129-B Enough is Enough Law, the survey collected information related to the following areas:

- Resources: availability of on and off campus
- Perceptions of risk
- Prevalence of prohibited conduct (Harassment, stalking, dating violence, domestic violence, assault)
  - Resource-seeking as a result of the experience
  - Satisfaction with the College’s response to reports and adjudication
- Prevention Education
- Bystander behavior and attitudes
- Demographic and background information






**Resources**


- St. John Fisher College has memorandums of understanding with RESTORE Sexual Assault Services and Willow Domestic Violence Center, both local victim support agencies located in Rochester. These off-campus resources are confidential.
- Respondents report great comfort using on-campus resources than off-campus resources.
- Students know less about off-campus resources than on-campus resources.





**Perceptions of Risk**

- **Students think that they are less likely to experience misconduct on campus than off-campus.**
- **33% of respondent disagree or strongly disagree that sexual misconduct is a problem at St. John Fisher College, compared with 28% of respondents that agree or strongly agree that it is a problem and 39% that neither agree nor disagree.**



**Prevalence of Prohibited Conduct**


- *The most prevalent conduct is offensive or insulting jokes, stories, remarks directly to a person or about a person’s body, appearance, or sexual activities.*
- *The least prevalent forms of conduct are the use of force for non-consensual sexual intercourse, and the threat of force for non-consensual sexual contact and sexual intercourse.*
- *Intimate Partner Violence (Dating or Domestic Violence) more often consists of controlling behavior and emotional manipulation than physical violence, though physical violence does happen and is never minimized or dismissed.*



### Disclosures and Reporting of Prohibited Conduct

- *Despite reporting that they are most comfortable with on-campus resources, when an incident does take place, students are most likely to not tell anyone or to tell a close friend or a family member.*
- *When students do not tell anyone, it is most often because they do not think the conduct is serious enough or that nothing will be done about it.*
